76.	OCC Councillor's Report Ms Lindsay Gale had circulated a report to Councils about OCC activities up to the end of August. She confirmed that there was no consensus between OCc and the Oxfordshire District Councils over possible changes to Local government organisation in the county. The Examination in public into the Minerals plan is now underway, with Ms Lindsay Gale attending where possible.		
	The new OCC COMET bus service appears to be being trialled successfully in Dorchester, where there is a bus running between Dorchester and Wallingford.		
	The Chairman outlined a recent Transport meeting at Culham, where members had indicated that they believed that the consultation into proposed changes to the T" bus services had been flawed to such an extent that the actions taken by OCC could be challenged in the Courts. Consultation had taken place into the removal of the T2 "loop" into Culham village, when it was the whole service that had been removed. AS the OCC subsidy had only applied to the Culham village loop, there was an assumption that the remainder of the service was viable, and therefore should have been retained. Removal is now causing concerns for the Head teacher of The Europa School at Culham, as there is no public transport available to take children to and from school. The group is now trying to persuade SODc to use its power of general competence to provide some pump priming to enable the service to re start with loops to include Dorchester and Culham Village.
